*For the \$10 Student Activity Card, you must waive it in WebAdvisor before the end of the second week of the semester. This fee is automatically added to your account if you do not waive it

*To waive the \$672.84 Medical Insurance, you must provide proof of your own insurance coverage to the Laura Thurman in Student Affairs (Welcome Center in SAC East) before the end of the second week of the semester. Coverage must be unlimited per injury or accident and include evacuation and repatriation benefits.

TUITION AND FEES

MANDATORY FEES

(Set by the California Legislature and subject to change)

1. TUITION

California Residents \$46.00 per unit

Non-Residents of California.....\$280.00 per unit

International Students\$286.00 per unit
(\$280 non-resident tuition plus \$6 capital outlay fee)

AB540 Students:

Under the provisions of AB540, certain nonresident students who have attended high school in California for 3 years or more are exempt from paying nonresident tuition. To find out if you qualify to pay the \$46 per unit fee instead, visit the information web page:

2. HEALTH SERVICES FEE..... \$20

The Student Health Services fee provides access to a variety of services. For more information about these services, visit the Student Health Services website:

Ed Code Section 76355 allows exemption from this fee solely to those students who depend upon prayer for healing in accordance with the teachings of a bona fide religious sect, denomination, or organization. An Appeals Petition is available in the Student Health Center. Documentation of religious affiliation is required. Board of Governors' Waiver (BOG) students will be charged the Health Services fee.

3. STUDENT CENTER FEE\$1 PER UNIT

The Student Center fee is required of all students and is designated solely for the purpose of funding services and activities sponsored by Associated Students of Cabrillo College. The fee is \$1 per unit up to a maximum of \$5 per semester (fall and spring only) and will not exceed \$10 per academic year. Board of Governors' Waiver (BOG) students will be charged the Student Center fee.

4. STUDENT REPRESENTATION FEE \$1

This fee is authorized by the legislature for students to lobby for student rights.

5. TRANSPORTATION FEE \$40

This fee is authorized by the legislature for students and provides each student with a bus pass valid seven days a week including during Winter Break periods. Santa Cruz Metro provide services throughout Santa Cruz County with transfer to Monterey-Salinas Transit. During the fall and spring semesters, students pay \$40. Summer session is \$20. A Cabrillo ID card with a current semester sticker is required to ride the bus. Semester stickers are available in the Welcome Center (SAC East, Second Floor).

**6. INTERNATIONAL STUDENT INSURANCE FEE
(Applies to International Students with F-1
visas only) \$672.84**

International students with F-1 visas are required to have adequate health insurance while studying in the United States. This insurance premium will be added to registration and tuition fees at the beginning of the fall and spring semesters. The International Insurance brochure and information can be found at

**7. CAPITAL OUTLAY FEE
(Applies to citizens and residents of another
country) \$6.00 per unit**

Education Code section 76141 authorizes a community college district to charge a fee to nonresident students who are either citizens or residents of a foreign country to offset capital outlay expenses. Nonresidents who are citizens and residents of a foreign country pay a \$6 capital outlay fee which is added to the \$280 nonresident tuition fee. The capital outlay fee may be waived for economic hardship, or for victims of persecution or discrimination in their home countries.

TUITION AND FEES *(continued)*

OPTIONAL FEES

(These fees can be waived when registering for classes)

1. PARKING PERMIT \$40

A student may purchase a semester parking permit for \$40 (\$20 for BOG students). A student who does not purchase a semester parking permit can pay \$4 per day to park in a student parking lot.

2. CHILDREN’S CENTER FUND \$2

This fee was approved by student government to assist Cabrillo College students with campus childcare. Every \$2 collected provides direct childcare assistance to students who might otherwise be unable to enroll in classes at Cabrillo College.

3. STUDENT ACTIVITY CARD* \$10

The Student Activity Card (SAC) is your key to many great discounts and services in the community including free admission to Cabrillo athletic events! It also supports student scholarships and events held by the Associated Students of Cabrillo College. *This optional fee is automatically charged to each student but can be waived.

How Can I Pay for My Tuition and Fees Costs?

You can pay your tuition and fees using cash, Visa/Master-Card, check, or a money order. There are several ways to pay your fees. You can use WebAdvisor, the Welcome Center, secure drop boxes at each of the Cabrillo College locations, Watsonville or Aptos, or by mailing a check to: Cabrillo College Welcome Center, 6500 Soquel Drive, Aptos, CA 95003.

Tips on Dropping a Course and Paying Your Fees

Were you billed for classes you forgot to drop? If you enroll in a class and then change your mind and decide not to attend it, you need to officially drop the class before the refund deadline. Otherwise, you are responsible for paying the fees. We do not automatically drop you from classes you have not paid, and an outstanding balance may prevent you from registering.

Refunds for Dropping a Course

Students must officially drop a course by the deadline to be eligible for a refund. Drop dates vary depending on the length of the course. Short-term courses, including all summer courses, have much earlier deadlines than full-term courses. Please check the Admissions and Records web page for semester dates and deadlines:

We charge a \$10 processing fee for refunds, except for cancelled classes and fees collected in error. If you paid your fees via WebAdvisor using a credit card within the last 120 days, we will refund your credit card. In all other cases, refunds will be processed via BankMobile.

We begin processing refunds the week following the last day to add/drop for the semester. If you drop by that deadline, you should expect your refund within 30 days of the deadline.

Parking Permit Refunds

Return the parking permit to the Welcome Center (SAC East) in person by the appropriate deadline to be eligible for a refund. Unfortunately, we cannot issue you a refund after the deadline, even if you never picked up the parking permit.

Refund or Credit of the Student Activity Card Fee

The \$10 Student Activity Card fee will be refunded if you drop all of your classes before the first day of the term. Before the term begins, you may also decline the fee on WebAdvisor ("Decline Student Activity Card Benefits") or in person at the Welcome Center.
